SECTION 4. First aid measures

4.1. Description of first aid measures

Skin: Wash the skin thoroughly with soap and water. If symptoms arise, request medical assistance

8.2. Exposure controls

As the use of adequate technical equipment must always take priority over personal protective equipment, make sure that the workplace is well aired through effective local aspiration.
